## Spring Show Information

(3 pages of information)

- ❖ Horses are allowed on the show grounds **no earlier than 3:00 PM** on Thursday, May 2<sup>nd</sup>. **Riding is not permitted on Thursday.**
- ❖ Horses must be off the show grounds 1 hour after the show concludes on Sunday, May 5<sup>th</sup>.
- ❖ **Pre entries close Wednesday, April 24<sup>th</sup>.** All entries received after this will be charged a post entry fee of \$30/entry.
- ❖ Scratches prior to the close of entries will receive a full refund. Scratches after the closing of pre-entries will be refunded entry fees, however, the \$30 office fee will still apply and stall fees will not be refunded. NO EXCEPTIONS.
- ❖ Returned checks will be charged a fee of \$100. Payment of return fee and initial amount shall be made within 2 weeks of notification.
- ❖ All prize money will be applied to show bill. Excess winnings will be mailed within 30 days.
- ❖ Horse Show Office will open ½ hour prior to start time, and close 1 hour after the end of the show day. All stall, hay, and/or shavings splits must be made by the end of the show day on Friday.
- ❖ Unjudged warm ups are offered at times posted on the class list at \$20 per round.
- ❖ Horses on the grounds but not showing, will be charged a grounds fee of \$50.
- ❖ Horse Health Requirements include negative coggins within 12 months; EIV (Equine Influenza) and EHV-1/EHV-4 (Rhinopneumonitis) vaccines within 6 months. In addition, horses must have shown no signs of infectious disease and may not had a fever above 102 degrees F within 72 hours of arrival.
- ❖ Stabling will be assigned on a first come, first served basis.
  - ❖ Stalls are \$185 if payment is mailed with stall form prior to closing date for entries – April 24<sup>th</sup>. Stalls increase April 25<sup>th</sup> to \$205 each. Open checks will not be accepted for stall fees. **No refund of stall fees after the closing date of entries...no exceptions.** Stall fee includes night watch.
  - ❖ **Hay and Shavings available for purchase by pre-order only, and are non-refundable.** Hay and Shavings must be pre-ordered on stall form by April 24<sup>th</sup>.
  - ❖ **No altering of stalls is permitted without authorization by fairgrounds. All alterations must be made by fairgrounds staff with a charge of \$25/panel.**
  - ❖ **All owners and exhibitors will be held responsible for any damages incurred by them, their agents or employees to buildings, stalls, rings and other properties on show grounds, and will be billed accordingly.**
  - ❖ There will be a \$25 fee for staples used on stalls.
  - ❖ Extension cords must be grounded (three wire/prong).
  - ❖ Per fairgrounds policy, aiseways must be kept clear. Tack and equipment are not permitted in the aisles.

- ❖ Helmets must meet or exceed ASTM/SEI safety standards and be worn at all times while mounted. Chin straps must be securely fastened.
- ❖ Dogs must be leashed at all times, attached to a human or tied. **Dogs are not permitted in the indoor arena.**
- ❖ Parking is allowed only in designated areas. Loading and unloading is permitted next to the barns, otherwise that area is to be left clear of all vehicles.
- ❖ Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. Violations of this rule will be cause for sanctions against the parent(s), guardian(s) and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Chapter 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.
- ❖ NHHJA management reserves the right to limit entries, cancel, combine, or split any class, section or division; to add a dotted line, to reschedule classes, change rings or change specifications in jumper classes due to time constraints.
- ❖ NHHJA horse shows abide by the rules and regulations of the New England Horsemen's Council.
- ❖ All entries are required to pay \$3 fee to USHJA, \$2 fee to NEHC and \$1 fee to MHC.
- ❖ Lungeing and schooling will only be permitted in designated areas.
- ❖ RV spaces are available for a fee of \$125/camper up to 35 feet and \$150/camper over 35 feet long. Each camper must have a reservation form sent to the horse show secretary and be pre-paid either by credit card or check in order to secure a camper spot. Camper spots are NON-REFUNDABLE after the closing date of the horse show. Each reservation will be assigned a camper pass and can be picked up at the horse show office. This pass must be displayed in your camper at all times.
- ❖ Payment by credit card will be accepted. There will be a 3% fee of the amount charged for this service.
- ❖ All entries for NEHC medal classes must have their membership number or a copy of their temporary membership card with them. Entries without membership numbers will not be accepted. If you know you are a member and cannot remember your number, you can fill out a Membership Affidavit. There is a \$25.00 fee which will be returned to you when your membership is validated. If you join NEHC at the horse show, please make sure you get your Temporary Membership from the show office.
- ❖ All incidents on show grounds must be reported to management. This includes any accidents, injuries and property damage.
- ❖ Exhibitors will be financially responsible for any property damages caused by them, or their horse(s). Repair expenses will be billed accordingly, if not during the event, then immediately afterward. Failure to pay will result in suspension of membership until debt is paid in full.
- ❖ **In order to accumulate points, membership fee MUST be paid AND membership form MUST be completed prior to the conclusion of the show. Note: Juniors need parent signature.**
- ❖ **This is a USHJA Outreach competition. See USHJA website ([www.ushja.com](http://www.ushja.com)) for more information. A list of Outreach pointed classes/divisions for this show can be found in the show office.**

- ❖ **The United States Equestrian Federation (USEF, [www.usef.org](http://www.usef.org)) requires ALL persons mounted on a horse to wear properly fitted ASTM approved helmet with harness secured. NHHJA follows suit.**
- ❖ **Trophy or prize money and six ribbons will be awarded in each class.**
- ❖ **Champion and Reserve Champion will be awarded in all divisions with three or more classes.** In hunter divisions, at least two over fences classes and the under saddle class must be completed in order to award division championships.

# 2024 NHHJA HORSE SHOW CLASS DESCRIPTIONS

## Equitation Classes

No rider may enter classes for more than one age group. The exhibitors' age for competition will follow NEHC rules, age as of December 1st. Points can be accumulated only in the age group indicated on the application for membership. Martingales are prohibited on the flat.

---

**\*Equitation Prep** - This class is designed as a warm up round, and therefore, is open all riders, regardless of status. To be shown over an equitation type course. To be open all day, or as specified, and run at current fence heights. Riders must specify that their round is a Prep round. Only one round is permitted per horse, unless time allows. Ribbons will not be awarded for Prep classes. *(Non Pointed NHHJA)*

**\*Lead Line Equitation/Lead Line Suitability** – Open to riders 8 years of age and under. To be shown at the walk and trot. Not to show in any other class/division at the same show. Leader and side-walkers must be over the age of 14 and appropriately dressed. Riders may not have competed off the lead.

**Hunt Seat Walk-Trot Equitation (Outreach Walk Trot)** – Open to riders 10 years of age and under. Shall show at a walk and trot only. Reverse at walk. No child entered may compete in any other class requiring entries to canter or lope. Rider must not have EVER been judged in a class at a ANY show that required a canter on the show grounds or warm-up. No tests will be called. NEHC/MHC “A”

**Hunt Seat Walk-Trot Equitation Championship (Outreach Walk Trot)** – same specifications as Hunt Seat Walk-Trot Equitation class above. Must have entered, shown, and judged in the Hunt Seat Walk-Trot class in order to show in the Hunt Seat Walk-Trot Equitation Championship class. NEHC/MHC “A”

**Short Stirrup Equitation (Outreach 18” Equitation)** – Open to riders 12 years of age and under. Riders cannot have shown higher than 18” at any recognized show. NEHC/MHC “A”

**Short Stirrup Equitation Flat** – to be judged at the walk, trot and canter in both ways of the ring. May be asked to halt and back. No more than 8 to canter at one time.

**Short Stirrup Equitation O/F** – to be shown over a minimum of 4 fences and a maximum of 8 fences, with fences not to exceed 18” in height. Fences may be taken at a trot or canter.

**\*Long Stirrup Equitation (Outreach 18” Equitation)** – Open to riders 13 years of age and older. Riders cannot have shown higher than 2’ at any recognized show.

**Long Stirrup Equitation Flat** – to be judged at the walk, trot and canter in both ways of the ring. May be asked to halt and back. No more than 8 to canter at one time.

**Long Stirrup Equitation O/F** – to be shown over a minimum of 4 fences and a maximum of 8 fences, with fences not to exceed 18’ in height. Fences may be taken at a trot or canter.

**Hunt Seat Equitation Under 12 (Outreach 2' Equitation)** – fence heights not to exceed 2'. NEHC/MHC "A"

**Hunt Seat Equitation 12-14 (Outreach 2'9" Equitation)** – fence heights not to exceed 2'9". NEHC/MHC "A"

**Hunt Seat Equitation 15-17 (Outreach 3' Equitation)** – fence heights not to exceed 3'. NEHC/MHC "A"

**Amateur Adult Equitation (Outreach 2'9" Equitation)** – fence heights not to exceed 2'9". NEHC/MHC "A"

**\*Modified Children's Equitation (Outreach 2'3" Equitation)** – fences not to exceed 2'3". Open to junior riders who have never shown higher than 2'6" at any recognized show.

**Modified (Low) Amateur Adult Equitation (Outreach 2'3" Equitation)** – fences not to exceed 2'3". Open to amateur riders 18 years of age and older who haven't shown higher than 2'6" at a recognized show in the current show season. Riders in this division cannot show in any other classes at the same show where fences exceed 2'6". NEHC/MHC "A"

**Children's Equitation (Outreach 2'6" Equitation)** - fence heights not to exceed 2'6" for horses/large ponies, 2' for small/medium ponies. Open to junior riders who have never shown higher than 3' at any recognized show. NEHC/MHC "A"

## Qualifying Medal Classes

- *Must be a member to accrue points for finals* -

**\*NH Adult Medal** – fences not to exceed 2'9". Amateur riders 18 years of age and older must accumulate 10 points in order to qualify for NH Medal Finals. Riders will be required to perform over a minimum of 8 fences with at least one change of direction. At least three (3) riders must complete the course. Testing is optional and is at the discretion of the judge. USEF Tests 1-23. *NH Adult Medal and NH Junior Medal may be combined if there are not enough entries to fill them separately. To be shown at respective height.*

Note: When rider wins Adult medal class at year-end finals, he/she must skip one (1) year of competing in the class at the finals, but may return to compete in the class the following year.

**\*NH Junior Medal** – fences not to exceed 3'. Junior riders must accumulate 10 points in order to qualify for NH Medal Finals. Riders will be required to perform over a minimum of 8 fences with at least one change of direction. At least three (3) riders must complete the course. Testing is optional and is at the discretion of the judge. USEF Tests 1-23. *NH Junior Medal and NH Adult Medal may be combined if there are not enough entries to fill them separately. To be shown at respective height.*

Note: When rider wins Junior medal class at year-end finals, the rider no longer eligible to compete in the class again at finals.

**\*NH Children's Medal** - fence heights not to exceed 2'6" for large ponies/horses, 2' for small/medium ponies. Open to junior riders who have never shown higher than 3' at any recognized show. Children's riders must accumulate 10 points in order to qualify for NH Medal Finals. Riders will be required to perform over a minimum of 6 fences with at least one change of direction. At least three (3) riders must complete the course. Testing is optional and is at the discretion of the judge. USEF Tests 1-8. *NH Children's Medal, NH Modified Children's Medal and/or NH Modified Adult Medal may be combined if there are not enough entries to fill them separately. To be shown at respective height.*

Note: If a rider wins Children's medal class at year-end finals two (2) years consecutively, the rider is no longer eligible to compete in class again at finals.

**\*NH Modified Children's Medal** – fence heights not to exceed 2'3". Open to junior riders who have never shown higher than 2'6" at a recognized show. Must accumulate 10 points to qualify for NH Medal Finals. Riders will be required to perform over a minimum of 6 fences with at least one change of direction. At least three (3) riders must complete the course. Testing is optional and is at the discretion of the judge. USEF Tests 1-8. *NH Modified Children's Medal, NH Modified Adult Medal and/or NH Children's Medal may be combined if there are not enough entries to fill them separately. To be shown at respective height.*

Note: When rider wins Modified Children's medal class at year-end finals two (2) years consecutively, the rider is no longer eligible to compete in class again at finals.

**\*NH Modified Amateur Adult Medal** – fence heights 2'3"-2'6". Open to amateur riders 18 years of age and older who haven't shown higher than 2'6" at a recognized show in the current show season. Must accumulate 10 points to qualify for NH Medal Finals. Riders will be required to perform over a minimum of 6 fences with at least one change of direction. At least three (3) riders must complete the course. Testing is optional and is at the discretion of the judge. USEF Tests 1-8. *NH Modified Adult Medal, NH Modified Children's Medal and/or NH Children's Medal may be combined if there are not enough entries to fill them separately. To be shown at respective height.*

Note: When rider wins Modified Adult medal class at year-end finals, he/she must skip one (1) year of competing in the class at the finals, but may return to compete in the class the following year.

**\*NH Novice Medal** – fence heights not to exceed 18". Open to junior and amateur adult riders who have never shown higher than 2' at a recognized show. Must accumulate 10 points to qualify for NH Medal Finals. Riders will be required to perform over a minimum of 6 fences with at least one change of direction. At least three (3) riders must complete the course. Testing is optional and is at the discretion of the judge.

Note: When rider wins Novice medal class at year-end finals 2 years consecutively, he/she is no longer eligible to compete in the class again at finals.

ALL YEAR-END FINAL MEDAL CLASS WINNERS ARE STILL ELIGIBLE TO COMPETE IN MEDAL FINAL QUALIFYING CLASSES AT NHHJA HOST SHOWS, BUT MUST FOLLOW SPECIFICATIONS ABOVE FOR FINALS ELIGIBILITY.

**Downeast Walk-Trot Poles Medal** - Open to riders 10 years of age and under. Must not have shown over fences or cantered at any horse show. Contestants shall be required to show at a trot over a minimum of four rails (poles) on the ground. Testing optional, verbal testing recommended.

**Downeast Short & Long Stirrup Medal** - Open to junior and amateur adult riders. Riders 12 years of age and under must never have shown over fences that exceed 2'. Riders 13-17 must be in their first three years of showing over fences and must never have competed in a class or division with fences higher than 2'. Adults may not have shown in a class or division with fences higher than 2' in the current year or previous 3 years. Riders shall be required to perform a minimum of six fences with at least one change of direction. Fence height will be 18". Testing optional, verbal recommended. All adult equitation riders must have proof of amateur status from MHA, NHHJA, NEHC, USEF or any recognized breed organization. All ages (Short and Long Stirrup) may compete together at the qualifying shows, but age groups will be divided at the finals into 12 & under, and 13 & over through adults.

**Downeast Mini Medal** - Open to junior and amateur adult riders, competing on horses or ponies. Riders must not have competed higher than 2' anywhere. **All fence heights shall be 2'**. Riders shall be required to perform over a minimum of six fences with at least one change of direction. If a rider wins the medal final, they are no longer eligible to compete in this division. 25% of the contestants, at least 2, may be called back for individual testing. Testing is optional.

**Downeast Modified Junior Medal**- Open to riders 17 years of age and under, competing on horses or ponies. Riders must not have competed higher than 2'6" at a recognized show. Contestants shall be required to perform over a minimum of six fences with at least one change of direction. Fence heights will be 2'3". If a rider wins the medal final, they are no longer eligible to compete in this division. 25% of the contestants, a minimum of 2 riders, may be called back for individual testing. Testing optional. *Shows hosting qualifying classes may combine the Modified Junior Medal and the Modified Adult Medal if there are not enough riders to fill them separately.*

**Downeast Junior Medal** - Open to riders 17 years of age and under, competing on horses or ponies. Riders shall be required to perform over a minimum of six fences with at least one change of direction. **Fence heights shall be 2'6"**. **If a rider wins the Junior Medal final, they are allowed to return for a second year.** 25% of the contestants, a minimum of 2 riders, may be called back for individual testing. Testing optional. *Shows hosting qualifying classes may combine the Junior Medal and the Amateur Adult Medal if there are not enough riders to fill them separately.*

**Downeast Modified Adult Medal** - Open to amateur adult riders 18 years of age and older, competing on horses or ponies. Riders shall be required to perform over a minimum of six fences with at least one change of direction. Fence heights shall be 2'3". Riders must not have competed higher than 2'6" at a recognized show in the current year or previous 3 years. If a rider wins the medal final, they are no longer eligible to compete in this division. 25% of the contestants, at least 2 riders, may be called back for individual testing. Testing optional. All adult equitation riders must be amateurs as that term is defined in the current NEHC rule book. Riders must have available for inspection, proof of amateur status from MHA, NHHJA, NEHC, USEF or any recognized breed organization. *Shows hosting qualifying classes may combine the Modified Junior Medal and the Modified Adult Medal if there are not enough riders to fill them separately.*

**Downeast Amateur Adult Medal** - Open to amateur riders 18 years of age and older, competing on horses or ponies. Contestants shall be required to perform over a minimum of six fences with at least one change of direction. **Fence heights shall be 2'6"**. **Amateur Adult Medal Final is open to all adults, even those who have previously won the medal final.** 25% of the contestants, at least 2 riders, may be called back for individual testing. Testing optional. All adult equitation riders must be amateurs as that term is defined in the current NEHC rule book. Riders must have available for inspection, proof of amateur status from MHA, NHHJA, NEHC, USEF or any recognized breed organization. *Shows hosting qualifying classes may combine the Junior Medal and the Amateur Adult Medal if there are not enough riders to fill them separately.*

**NEHC Adult Medal** - Open to adult amateur members of the New England Horseman's Council. All contestants are required to perform over at least eight fences set at a height from 2'9" to 3' with a combination and two changes of direction after the first obstacle. One or more individual tests of the top four contestants may be requested at the judge's discretion. (USEF current tests 1-23). To fill a class, at least three competitors must complete the course. If there are not 3 riders of either or both the Junior or Adult Hunt Seat Medal qualifying class, they can be combined to meet the 3 rider minimum. Riders would show at their respective heights.

**NEHC Junior Medal** - Open to Junior members of the New England Horsemen's Council who have not reached their 18th birthday. All contestants are required to perform over at least eight fences set to a height from 3' to 3'3" with a combination and two changes of direction after the first obstacle. One or more individual tests of the top four contestants may be requested at the judge's discretion. (USEF current tests 1-23). To fill a class, at least three competitors must complete the course. If there are not 3 riders of either or both the Junior or Adult Hunt Seat Medal qualifying class, they can be combined to meet the 3 rider minimum. Riders would show at their respective heights.

**MHC Junior Hunt Seat Medal** - May compete after qualifying. Open to Junior members of the MHC who have not reached their 18th birthday. All contestants are required to perform over at least 8 fences not to exceed 3'. Ten points are required to qualify for the finals. To fill a class, at least 3 competitors must complete the course. If there is not a minimum of riders of either or both the Junior or Adult Medal qualifying class, the show can combine to meet the rider requirement. Riders will show at their respective heights. One or more individual tests of the top 4 contestants may be requested at the judge's discretion. (USEF tests 1-23).

**MHC Amateur Adult Hunt Seat Medal** - May compete after qualifying. Open to adult members of MHC. All contestants are required to perform over at least eight fences 2'6" to 2'9", with at least one change of direction. To fill a class at least three competitors must complete the course. If there is not a minimum of riders of either or both the Junior or Adult Medal qualifying class, the show can combine to meet the rider requirement. Riders will show at their respective heights. One or more individual tests of the top 4 contestants may be requested at the judge's discretion. (USEF tests 1-23).

**MHC Hunt Seat Mini Medal** – Open to members of MHC who have not reached their fifteenth birthday and have not competed in classes in which the entry is required to jump higher than three feet. All contestants are to compete over a course not exceeding eight fences and not less than six fences, excluding combination fences, at a height not to exceed 2'6" for ponies and horses. May compete after qualifying. Ten points are required to qualify for the finals. A Mini-Medal rider who competes in the Jr. Medal prior to the finals is no longer eligible for the Mini-Medal Final. To fill a class, at least three competitors must complete the course. One or more individual tests of the top 4 contestants may be requested at the judge's discretion. (USEF tests 1-23).

**MHC Adult Hunt Seat Mini Medal** - Open to adult members of MHC who have not jumped 2'9" or higher in the past 2 years. All contestants are to perform over a course not exceeding 8 fences and not less than 6 fences, excluding combinations and a height not to exceed 2'6" for horses and ponies. To fill a class 3 must complete the course. 10 points to qualify. May compete after qualifying. One or more individual tests of the top 4 contestants may be requested at the judge's discretion. (USEF tests 1-23).

**MHJ Short Stirrup Medal (class #54 qualifying class)** – Open to all junior riders who have not reached their 13<sup>th</sup> birthday as of December 1<sup>st</sup> of the current show year. To perform over at least four fences not to exceed 18". Riders **may not** compete in any other equitation class other than Short Stirrup Equitation, at any show and shall not have competed in a class jumping over 18". Any Short Stirrup Equitation class(es) or Championship class may be used as the qualifying Class as long as the show program specifies. At least 2 riders must complete the course in order for points to count. To qualify: 10points. Once qualified, riders may continue to show in the class.

**MHJ Mini Medal** – Open to all junior riders who have not reached their 15<sup>th</sup> birthday as of December 1<sup>st</sup> of the current show year [exception Maiden and Novice riders who have not reached their 18<sup>th</sup> birthday as of December 1<sup>st</sup> of the current show year.] To perform over at least six fences **not to exceed** 2'6". At least 2 riders must complete the course in order for the points to count. To qualify: 10 points. Once qualified, riders may continue to show in the class. Riders may cross-enter into the Children's equitation Medal but can only compete in either the Mini-Medal **or** Children's Equitation Medal **but not both at the finals**.

**MHJ Adult Mini Medal** - Open to all Adult Amateur riders that have not shown over a course where the fences exceeded 3' in the current year. To perform over a course of at least 8 fences not to exceed 2'6". At least 2 riders must complete the course in order for the points to count. Riders may not cross enter into the MHJ Adult Medal.

**MHJ Adult Medal** – Open to all Adult Amateur competitors to perform over at least 8 fences 2'9" to 3'0", spreads not to exceed fence height, with at least two changes of direction and a combination. At the finals, class will be divided 18-30 and 31 and over. At least 2 riders must complete the course in order for points to count. To qualify: 10 points. Once qualified, riders may continue to show in the class.

**MHJ Junior Medal** – Open to all junior riders who have not reached their 18<sup>th</sup> birthday as of December 1<sup>st</sup> of the current show year. To perform over at least six fences not to exceed 3'. At least 2 riders must complete the course in order for points to count. To qualify: 10 Points. Once qualified, riders may continue to show in the class.

**MHJ Children's Equitation Medal**– Open to all horses and ponies. Open to riders who have not yet reached their 18<sup>th</sup> birthday. Riders may not cross enter into junior equitation. Fences 2' for small/medium ponies, 2'6' for large ponies/horses. At least 2 riders must complete the course in order for the points to count.

## Pleasure Divisions

**Walk-Trot Pleasure (Outreach Walk Trot)** – Open to riders 10 years of age and under. To be shown at a walk, and trot ONLY. To be judged on manners, suitability or a horse/pony to rider and performance. Reverse at walk. No child entered may compete in any other class requiring entries to canter or lope at the current show. May not have cantered or loped in any class at a previous show. NEHC/MHC “C”

**Walk-Trot Pleasure Championship (Outreach Walk Trot)** – same specifications as Walk-Trot Pleasure class above. Must have entered, shown, and judged in the Walk-Trot Pleasure class in order to show in the Walk-Trot Pleasure Championship class. NEHC/MHC “C”

**\*Pony Hunter Pleasure Division** – open to all ponies of a hunter type ordinarily used for pleasure purposes. Adults are permitted to show ponies with suitability to count; light contact with the pony’s mouth is required. To be judged on performance, manners, quality, presence, suitability, substance and soundness. Open to ponies only. MHC “B”

**Pony Hunter Pleasure Under Saddle** – to be judged at the walk, trot and canter both directions of the ring. May be asked to hand gallop, halt and back.

**Pony Hunter Pleasure Championship** – specifications to be the same as qualifying class. To be eligible, ponies must have been entered, shown and judged in the Pony Hunter Pleasure U/S. Prize Money: \$20, \$15, \$10, \$5

**Hunter Pleasure Horse Division** – open to all horses of a hunter type ordinarily used for pleasure purposes with no limitations to status of rider. Light contact with horse’s mouth is required. To be judged on performance, manners, quality, presence, suitability, substance and soundness. Open to horses only. NEHC/MHC “B”

**Hunter Pleasure Horse Under Saddle** – to be judged at the walk, trot and canter both directions of the ring. May be asked to hand gallop, halt and back.

**Hunter Pleasure Horse Championship** - specifications to be the same as qualifying class. To be eligible, horses must have been entered, shown and judged in the Hunter Pleasure U/S. Prize Money: \$20, \$15, \$10, \$5

**NEHC Pleasure** – open to NEHC members and non-members. Open to all horses ordinarily used for pleasure purposes with no limitations as to the status of rider or place of residence. To be shown at a walk, trot and canter. Will be required to back. Loose rein on command of judge only, but without loss of contact. Shall be judged on manners, performance and quality in that order. *\*non pointed NHHJA* NEHC “C”

## Jumper Divisions

Prize Money in all jumper classes: \$50, \$25, \$15, \$10. Tables as noted on class schedule.

**\*Novice Jumper (Outreach .65 Jumper)** - Open to any horse or pony with no restrictions. Fences 2’-2’3”.

**\*Puddle Jumper (Outreach .75-.80 Jumper)** – Open to any horse or pony with no restrictions. Fences 2’6”.

**\*Schooling Jumper (Outreach .90-.95 Jumper)** – Open to any horse or pony with no restrictions. Fences 3’.

**Open Jumper (Outreach 1.0-1.05 Jumper)** – Open to any horse or pony with no restrictions. Fences 3”-3’3”.

## **Hunter Divisions**

- Prize money in stake classes is \$50, \$25, \$15, \$10. Other classes will be awarded trophy and 6 ribbons.
- Must have shown in all hunter over fences classes to be eligible to compete in division's stake class.
- At least two over fences classes and the under saddle class must be completed in order to award division championships.
- Fences must simulate obstacles found in the hunting field such as natural post and rail, brush, stone wall, white board fence or gate, chicken coop, aiken, hedge, etc... A ground line is recommended for all fences. The top element must be securely placed so that slight rubs will not cause a knockdown. Open jumper fences such as striped rails and bull's eye panels are discouraged. An in-and-out must never be the first fence.

**\*Hunter Prep** – This class is designed as a warm up round and is open all horses and riders. To be open all day, or as specified, and run at current fence heights. Riders must specify that their round is a Prep round. Only one round is permitted per horse, unless time allows. Ribbons will not be awarded for Prep classes. (*Non Pointed NHHJA*)

**\*Performance Hunter Division** – Open to any horse or pony with no restrictions. Fence heights not to exceed 3'3".

**\*Baby Green Hunter Division (Outreach 2'6" Hunter)** – Open to any horse or pony in their first two years of showing over fences. Horses and ponies qualify for the Baby Green division for a maximum of two years only. Horses and ponies may not cross enter in other divisions with jumps exceeding 2'6", and may not to have previously shown over fences exceeding 2'6" in height at any recognized show. Simple changes of lead should not be penalized. Fences not to exceed 2'6".

**\*Open 2'6" Hunter Division (Outreach 2'6" Hunter)** – Open to any horse or pony regardless of status. Fences not to exceed 2'6". (*Non Pointed NHHJA*)

**\*Schooling Hunter Division (Outreach 2' Hunter)** – Open to any horse or pony regardless of status. Fences not to exceed 2'. (*Non Pointed NHHJA*)

**\*Beginning Hunter (Outreach 18" Hunter)** – Open to any horse or pony without restrictions. To be shown over 4 to 8 fences not to exceed 18". Fences may be taken at the trot or canter. Simple changes of lead shall not be penalized. In Under Saddle and Pleasure classes, no more than 5 horses to canter at a time. (*Non Pointed NHHJA*)

**Short Stirrup Hunter Division (Outreach 18" Hunter)** – Open to riders 12 years of age and under. May not compete in any other hunter divisions in a jumping class where fences are higher than 18". May never have shown over fences higher than 18" at any recognized show. To be shown over 4 to 8 fences not to exceed 18". Simple changes of lead should not be penalized. No more than 8 to canter at one time in under saddle class. NEHC/MHC "AA"



**\*Suitable Hunter Division (Outreach 18" Hunter)** – Horse **and/or** rider may never have competed in a class with fence heights greater than 2' at a recognized show. To be shown over 4 to 8 fences not to exceed 18" with no combinations. May trot or canter fences. Simple changes of lead should not be penalized. No more than 8 to canter at one time in under saddle class.

**\*Pre Child/Adult Hunter Division (Outreach 2' Hunter)** – Open to junior or amateur adult exhibitors who have not previously shown over fences exceeding 2'6" in height at a recognized show. Open to horses and ponies to show over the same course. Fence heights not to exceed 2'.

**Modified (Low) Adult Amateur Hunter Division (Outreach 2'3" Hunter)** – Open to amateur riders 18 years of age and older who haven't shown higher than 2'6" at a recognized show in the current show season. Riders in this division cannot show in any other classes at the same show where fences exceed 2'6". Fences not to exceed 2'3"  
NEHC/MHC "B"

**\*Modified Children's Hunter Division (Outreach 2'3" Hunter)** – Open to junior riders who have not previously shown over fences exceeding 2'6" in height at a recognized show. Open to horses and ponies to show over the same course. Fences not to exceed 2'3".

**\*Open Special Hunter Division (Outreach 2'6" Hunter)** – Open to any horse or pony regardless of status. Fences not to exceed 2'6".

**Special Child/Amateur Adult Hunter Division (Outreach 2'6" Hunter)** – Open to junior and amateur adult horse/rider combinations who have never competed in a class with fence heights greater than 2'9". Horses and ponies to show over the same course. Fences not to exceed 2'6".  
MHC "B"

**Children's Hunter Pony Division (Outreach 2'/2'6" Hunter)** – Same judging specifications as Children's Hunter Horse division. Fence heights not to exceed 2' for small & medium ponies, 2'6" for large ponies. Ponies may not cross enter into the regular pony hunter division.  
NEHC/MHC "B"

**Adult Amateur Hunter Division (Outreach 3' Hunter)** – To be ridden by amateurs who are no longer eligible to compete as juniors. Horse/rider combinations are not eligible for any other NEHC rated hunter classes. Horses may be shown by a different rider in any other divisions or classes at the same show. To be judged on performance, soundness, manners and way of going, size of rider to mount and suitability as an amateur adult hunter. Horses may be jogged for soundness at the judge's discretion. Fence heights not to exceed 3'. Spreads not to exceed height of fence. Ponies may be ridden by adults, suitability to count. May be split 18-35 years of age and 36 years of age & over if entries warrant.  
NEHC/MHC "B"

**Children's Hunter Horse Division (Outreach 3' Hunter)** – To be shown by junior exhibitors, age as of December 1st of the current show year. Junior exhibitors 15-17 years of age must be eligible for intermediate equitation O/F (have not won 12 blue ribbons) as of Dec. 1st of the current show year. Fences not to exceed 3'0, spreads not to exceed fence height. If entries warrant, the division may be split at the discretion of the management. Same horse/rider combinations may not compete in any other NEHC rated division at the same show except equitation, jumpers, and pleasure. Horses may be shown by another rider in any other division at the same show. Jogging for soundness at the discretion of the judge. Shall be judged on performance and soundness.
